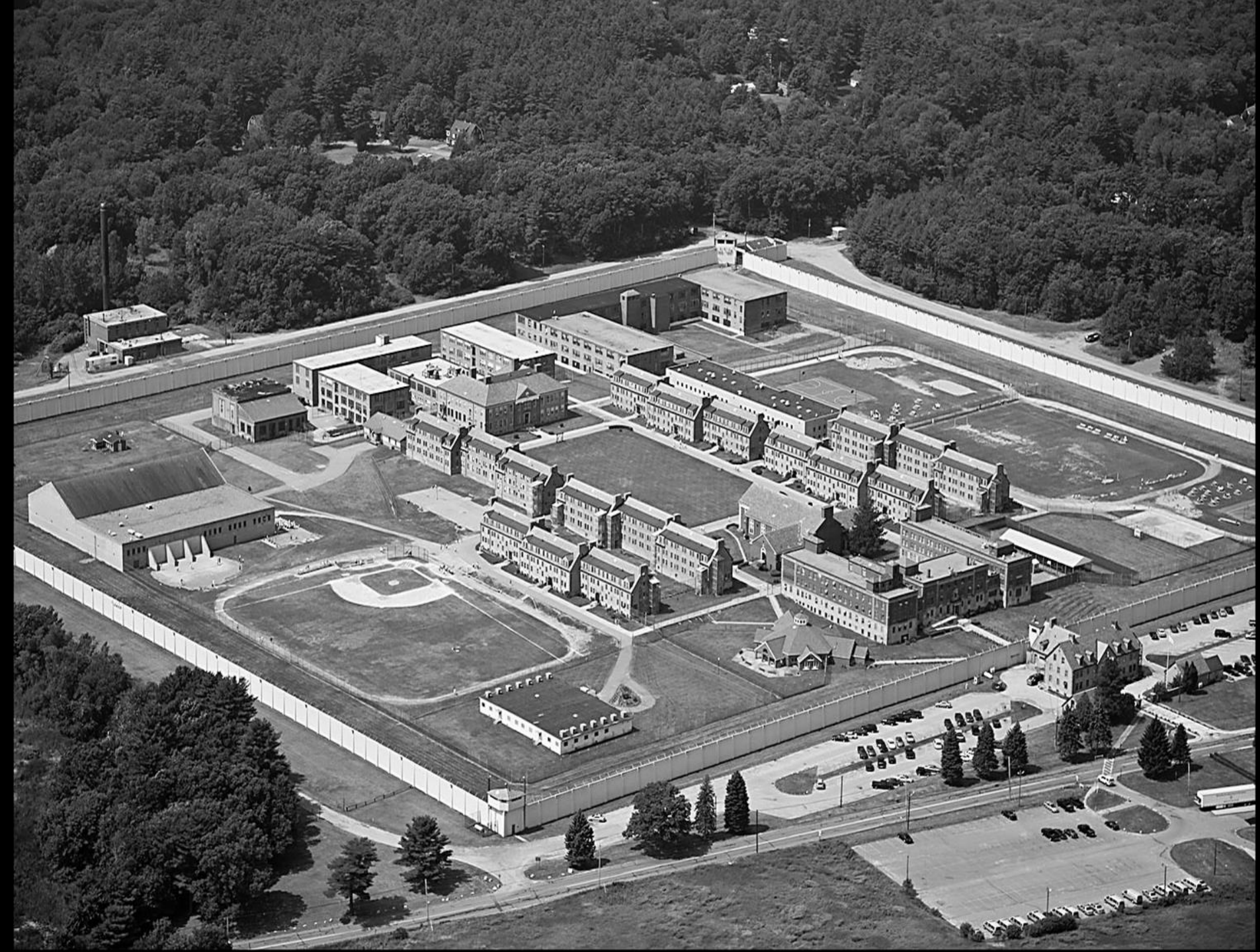

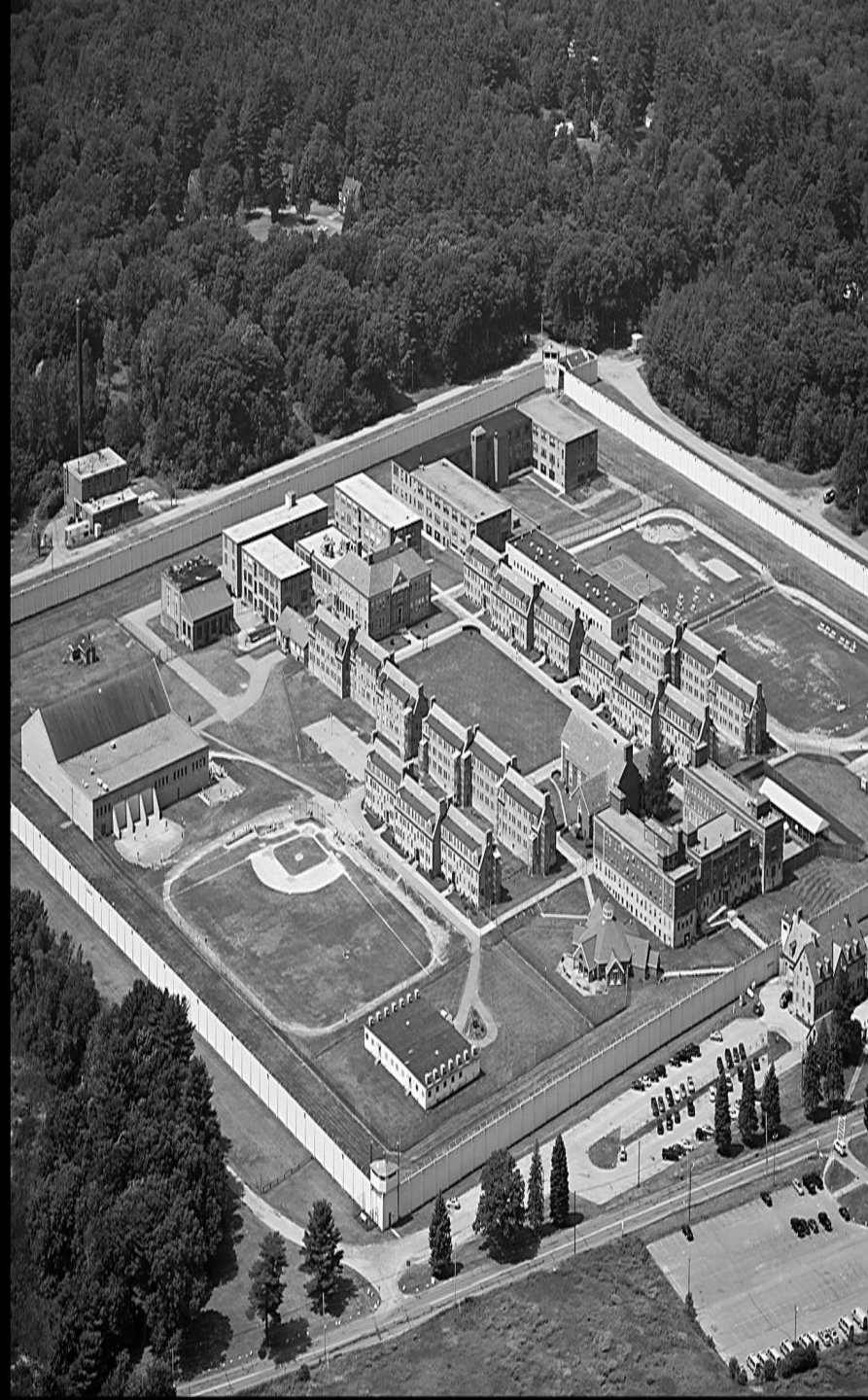

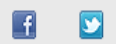
Dear Black America: A Few Thoughts on Ferguson
